## **ADMISSION TERMS – INTERNATIONAL BUYER/VISITOR**

These terms and conditions apply to visitor registrations for, and attendance at Expoalimentaria 2023.

Please carefully read the below admission policy before submitting your online registration for Expoalimentaria 2023. By submitting your registration and/or by attending an Event, you agree to be bound by these terms and conditions:

- Registration is compulsory for entry.
- Expoalimentaria is strictly for Trade and Business Professionals related to the industry only.
- General public and persons under the age of 18 will not be permitted entry.
- ADEX as organizer of Expoalimentaria 2023, strive to ensure that only qualified Trade
  and Business Professionals attend the exhibition to deliver a productive business
  environment for both visitors and exhibitors. We reserve the right to request further
  proof of eligibility prior to badge issue, and also to refuse entry if necessary.
- Your registration is issued for your personal use only. You may not sell or otherwise transfer your registration to others. Badges are non transferable and visitors found to be facilitating this will be not eligible for entry into Expoalimentaria 2023 or future editions
- If you do not receive your regsitration confirmation in your e-mail, please check your Junk folder (in some cases, your e-mail settings or system firewalls may cause our visitor confirmation e-mails to go to your Junk folder). For online registration support, please contact.
- Anyone attending the exhibition should carry some form of photo ID (passport, photo-ID driving license, national identity card) or other identification acceptable to the Organiser, which the Organiser may ask to see.
- You consent to filming, sound recording and photography at the Event, which may include, without limitation, filming, sound recording and photography featuring your image (the "Content"). You acknowledge and agree that Expoalimentaria is the sole and exclusive owner of all rights in the Content and hereby waive any and all: (a) rights in and to such Content, and (b) claims that you may have relating to or arising from the Content and/or its use. Without limitation, Expoalimentaria shall be permitted to use the Content anywhere in the World for promotional and other purposes, without any payment or compensation.
- The personal information that you provide to Expoalimentaria will be held by us on a database and, where we have appropriate authorisation/justification (which may include, without limitation, express/implied consent or legitimate interests) with government entities and regulatory authorities as required by law. At some Events, exhibitors and sponsors may use lead capture applications or barcode scanner devices. If you choose to allow your badge to be scanned by third parties at the Event, we may pass your personal information to such third parties. Further, there may be certain areas of the Event at which your attendance is conditional on your personal information being provided to third parties that have sponsored or are managing such areas. The use that any third parties make of your personal information is outside of Expoalimentaria control and, to the extent permitted by applicable law, we do not accept any liability in this regard.

• In case of any discrepancy between the English and other language versions of these terms and conditions, the Spanish shall prevail.

## **HOSTED BUYER PROGRAM**

- Every visitor registered as a buyer and applicant for the Hosted Buyer program must understand that the mere fact of being registered does not imply that he/she will automatically receive all the benefits assigned by the program.
- The selection of buyers benefiting from the Hosted Buyers program is determined according to the participation criteria established by the Organization: professional profile, company's economic data (e.g. volume of imports and purchases), products of interest, geographic area, limit of seats and budgetary restrictions. The final decision is taken by the Organization.
- The program considers 3 benefit categories as follows:
  - B3: Free access to the fair, corporate rates at official fair hotels, airport-hotel transfer, hotel-fair-hotel transfers.
  - o **B2:** Covered accommodation during the days of the fair, airport-hotel transfer, hotel-fair-hotel transfers.
  - B1: Air ticket (round trip) to visit the fair, corporate rates at official fair hotels, airport-hotel transfer, hotel-fair-hotel transfers.
  - VIP: Air ticket (round trip) to visit the fair, covered accommodation during the fair days, corporate rates at official fair hotels, airport-hotel transfer, hotel-fair-hotel transfers.
- Any other expenses that the Organization has not committed to cover when confirming acceptance into the program shall be borne by each participant.
- Any buyer who benefits from the Hosted Buyer program must confirm acceptance of the benefit within 24 hours of receiving notification.
- Each Hosted Buyer is obligated to:
  - Visit the fair at least two days and present themselves to the Organization.
  - Participate in at least 10 meetings with exhibitors of interest. The planning of the agenda of meetings will be done prior to the visit, through the platform, under the supervision of the organization.
- In case the beneficiary buyer cancels his participation once the organization has incurred expenses (air ticket issuance), he will have to pay the total amount of the fees upon cancellation.
